1. Overview

This manual aims to provide importers and local manufacturers with:

1. An overview of the Kingdom of Bahrain's excise rules and procedures in regard to the Digital Stamps Scheme.
2. The necessary guidance needed to navigate the Digital Stamps Scheme online portal and the process of ordering and tracking digital stamps from the perspective of an importer of excise products.

This manual is intended to provide general information only and does not represent exhaustive or legally binding guidelines.

2. Digital Stamps Scheme

The Digital Stamps Scheme is a supervisory system to track excise goods from the manufacturing stage to the point of consumption to limit smuggling instances within the Kingdom of Bahrain, thereby reducing the possibility of Excise evasion.

According to this scheme, a digital stamp is placed to contain security features and codes to prevent the circulation of inauthentic excise goods, as the digital stamps will be scanned at the Kingdom of Bahrain entry points to ensure the authenticity of these goods, as well as the efficient and timely collection of due government revenues.

Moreover, digital stamps will also enable consumers to identify product data by scanning stamps and ensuring the authenticity of such products.

The Digital Stamps Scheme will initially be applied to cigarette products. Later, its applicability will be extended to include Shisha and other tobacco products, such as E-cigarette consumables.

Registration for the Digital Stamps Scheme is required by excise payers and their relevant supply chain organizations who import or locally produce tobacco products from production or point of import to the release of products in the local market of the Kingdom of Bahrain.

Importers and local producers who are required to register for the scheme will receive access to the digital stamp's online portal upon completion of the training sessions required to use the portal.

2.1. Implementation of key milestones

In accordance with Decision No. (3) for the year 2022 regarding the implementing key milestones of the Digital Stamps Scheme on excise products (cigarette), the implementation key milestones will be as follows:

- **Receiving Digital Stamps orders milestone (11th March 2022):**

The system started to receive the digital stamps orders from excise payers registered with the National Bureau for Revenue through an electronic system, while allowing the trade of products that do not contain stamps in the local markets.

- **Imported cigarette products implementation milestone (17th July 2022):**

All cigarette products arriving at the Kingdom of Bahrain Customs Affairs for clearance must have the digital stamps placed.

- **Local markets implementation milestone (16th October 2022):**

All cigarette products available for sale in the local market must be placed with digital stamps. At this stage, no cigarette products can be sold in the local market without the digital stamps placed.

Also, any cigarette products that do not have digital stamps placed must be returned through the relevant supply chain to be destroyed or moved for sale outside the territory of the Kingdom of Bahrain.

2.2. Treatment of products imported to the Kingdom of Bahrain

Taking into consideration the above implementation key milestones, importers are required to follow the below guidelines of digital stamps requirements on imported products to ensure effective implementation of the Digital Stamps Scheme:

2.2.1. Cases that require digital stamps to be placed on cigarette products

- Imported cigarette products from the 17th of July 2022.
- Cigarette products are placed for sale at duty-free shops and later sold with the intention of circulating the products in the Kingdom of Bahrain markets for commercial purposes.

2.2.2. Cases that do not require digital stamps to be placed on cigarette products

- Imported products not intended to be circulated in the Kingdom of Bahrain markets and are placed in a Customs warehouse under a suspension regime to be re-exported are not required to place a digital stamp.
- Cigarette products are placed for sale at duty-free shops and later sold for personal use.

2.2.3. Procedures that will not be impacted by the implementation of the Digital Stamps Scheme

- Loss and destruction of excisable products under Customs suspension regime.
- Transportation of excisable products from duty-free and warehouse without the intention of circulating the products in the Kingdom of Bahrain market.

2.3. Errors, Deactivation and Cancellation of digital stamps

There are specific cases in which digital stamps can be deactivated/canceled. As stated in Decision No. (1) for the year 2022 under Article No. (7) regarding digital stamps for excise products, digital stamps are to be invalid or cancelled in the following cases:

Deactivated

- Digital stamps are obtained in a manner that is not in accordance with provision of this decision.

- Digital stamps are not placed on products or activated within 12 months from the digital stamps purchase date.
- Other situations are determined by the NBR.

Cancelled

- For the cases mentioned above.
- For cases where an error is incurred during the process of activating the digital stamp.
- Digital stamps are damaged in the production process.
- The excisable products on which the digital stamp is placed are exported.
- The excisable products on which the digital stamp is placed are destroyed prior to being traded in Kingdom of Bahrain markets.
- Other situations are determined by the NBR.

To deactivate/ cancel digital stamps, a request must be submitted for the NBR's approval through the following email: excise@nbr.gov.bh. Further information might be requested to approve the request.

Error detected while scanning the digital stamps:

For cases where an error arises while scanning the digital stamps that are placed on imported excisable products at the point of entry, the importer/local manufacturer will be responsible for contacting the NBR via email to ds@nbr.gov.bh and the NBR will investigate the issue and revert with the necessary action.

2.4. Registration of importers and local manufacturers

Importers and local manufacturers that are required to be registered for the Digital Stamps Scheme are requested to fill the Digital Stamps Scheme registration form available on the NBR website and share the filled form via email to ds@nbr.gov.bh.

The request will be reviewed by NBR to ensure correctness of the provided information. Importers and local manufacturers will be contacted through contact details provided in the form to provide further information (if required) and to schedule the training on the Digital Stamps System functions.

User ID and full access to the Digital Stamps System will be granted after the completion of the training.

3. Digital Stamps System Functions

3.1. Creating an Order

It is the responsibility of the importer to order digital stamps on behalf of international manufacturers to apply to the excisable products. In this process of creating an order for digital stamps, the importer must select the manufacturer and manufacturer's site that will apply the digital stamps to the excisable products the importer has ordered.


Once an order has been placed, NBR will review the order, once the order is approved, it will be processed and dispatched to the manufacturer.

Please note that when ordering digital stamps for cigarette products this will automatically order the digital codes for the same quantity. Digital codes are unique identifying codes that are printed directly to the cigarette packs by the manufacturer during production.

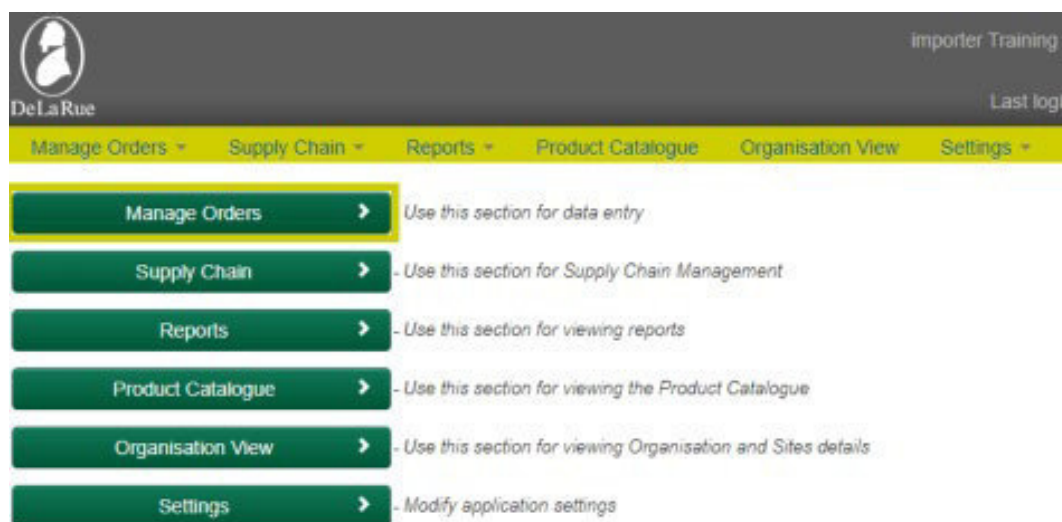
3.1.1. Steps of Creating an Order

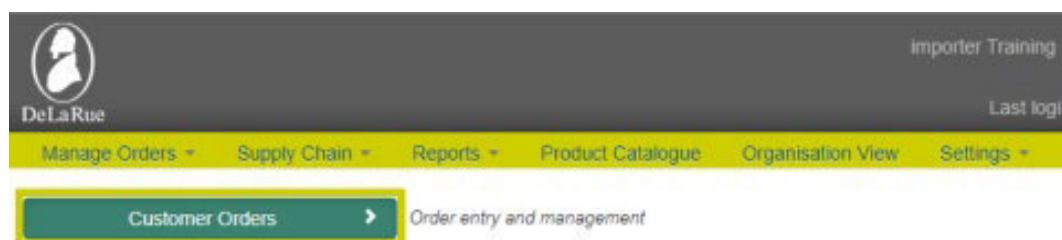
Once the training has been completed, login details will be shared. Importers and local manufacturers should log into the Digital Stamps System using their User ID and password.



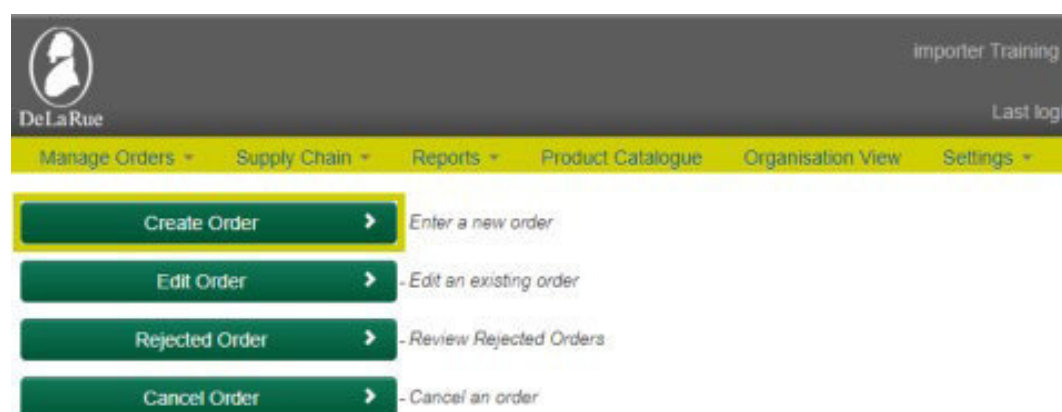
Importers and local manufactures should click on “Manage Orders” to initiate the ordering process

3.4. Edit and Resubmit a Rejected Order

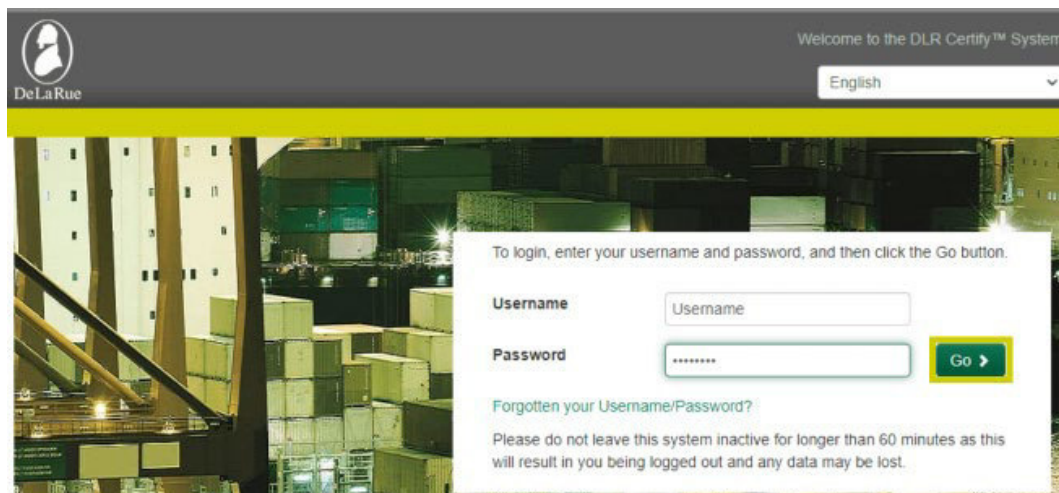
The following process will show how to edit and resubmit a rejected order by the NBR for digital stamps through Digital Stamps System.

The NBR may reject orders placed for digital stamps if an error is noticed within the order or it does not meet the approval criteria. Upon rejection of the order notification will be sent to notify the importers and local manufactures that the placed order has been rejected. To proceed with the order, the importers and local manufactures may resubmit the order by amending the reason it was rejected, or doing nothing, and the order will remain rejected and will not progress.

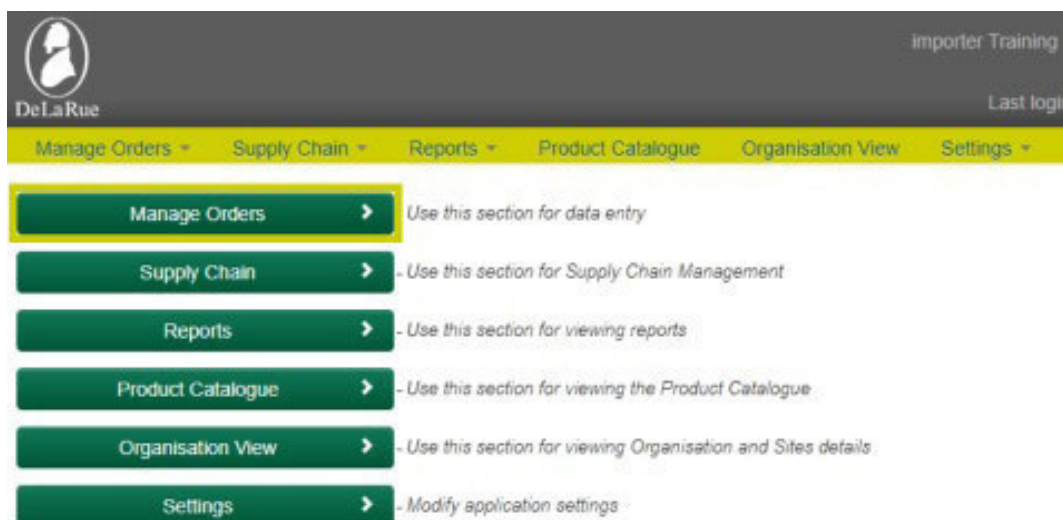
3.4.1. Steps to Edit and Resubmit a Rejected Order

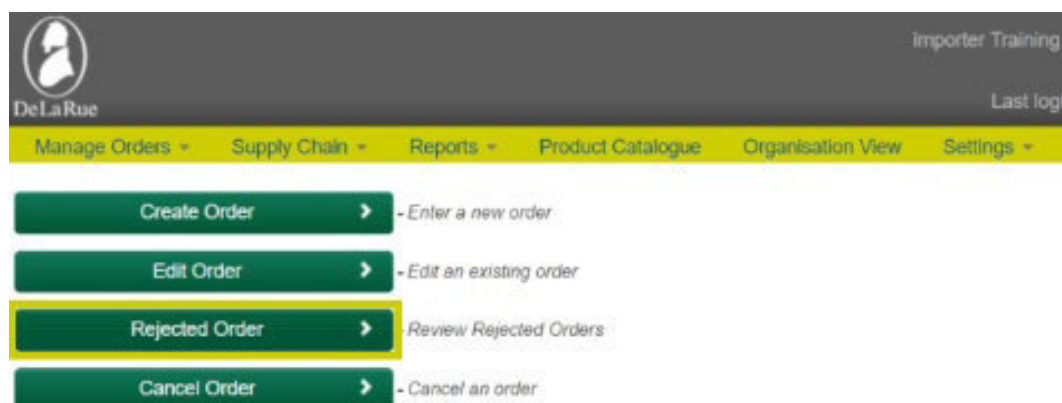

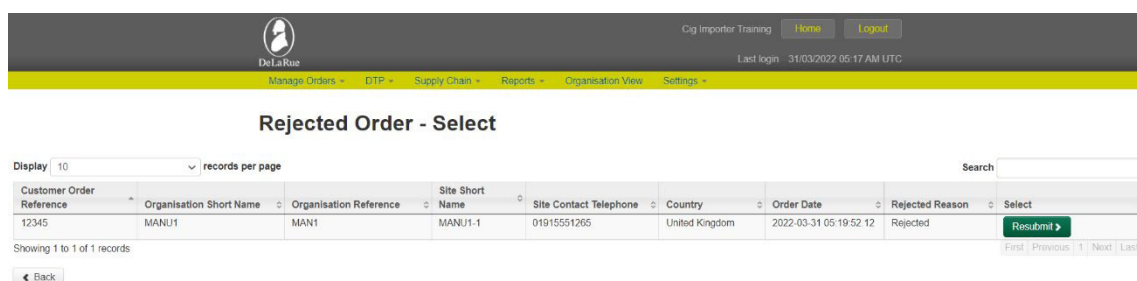


Then, click on “Rejected Order”.

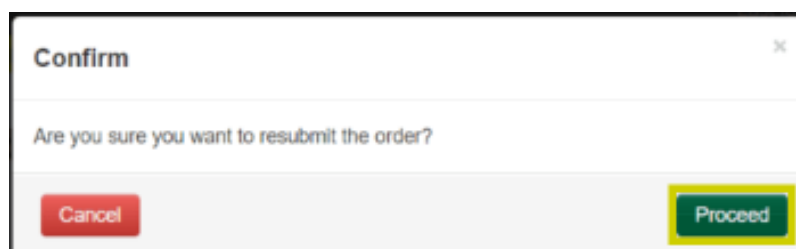


“Rejected Order – Select Order” page will be displayed. This page will show all orders rejected by NBR and have not yet been resubmitted.
